SPECIAL ORDER OF THE DAY:

Dr. Kurt Keppler, Vice President for Student Affairs and Chair-Elect Rebecca Kimbrough announced the five nominees for Employee of the Semester (Fall 2002). The nominees were Blanche Thomas (College of Education Dean s Office), Mary Jane Keene (Center for Teaching and Learning/Faculty Development), Ronald Butler (Central Warehouse), Ted Davis (Campus Mail), and Ben McCranie (Plant Operations). Dr. Keppler announced that Ronald Butler was the Employee of the Semester for Fall 2002 and presented him with a certificate of appreciation, a check for \$100.00, and a special parking permit. COMMITTEE REPORTS:

<u>Academic Scheduling/Procedures:</u> Shannon McGee informed everyone that a meeting of this committee has been rescheduled for March 6, 2003.

<u>Elections</u>: Mike McKinley distributed a form indicating the Representative positions that will be up for election in June. On-Line elections will be held during the first week of June 2003. In addition, there will be two polling stations open on Friday June 6, 2003. The location of the polling stations will be announced at a later date.

<u>Faculty Senate</u>: Shannon McGee informed everyone that a meeting of the Faculty Senate is scheduled for February 20, 2003.

<u>Parking Appeals:</u> Mike McKinley distributed a chart indicating the breakdown of the parking appeals for the month of January 2003. The committee upheld 51% of the appeals while 49% of the appeals were dismissed.

<u>Partners for Campus Excellence:</u> Shannon McGee indicated that she had recently received a letter from Becky Murphy regarding Partners for Campus

Excellence. Shannon stated that she would contact Becky and invite her to the next COSA meeting to update everyone on Partners for Campus Excellence.

<u>Policy</u>: Bob Lee indicated the Policy committee will be recommending some changes regarding elections. The committee will also be discussing an issue regarding third year past chair.

<u>State Charitable Contributions Program:</u> Bob Lee informed everyone that the books have now been closed on the 2003 State Charitable Contributions Program. There will be fundraisers held during the spring and summer to raise money for the 2004 State Charitable Contributions Program.

<u>Welfare Committee:</u> Rebecca Kimbrough asked the chairs of each Welfare subcommittee to give a report each month. She also informed the group that it has been suggested the next Cosa-On-The-Move meeting be an open meeting that would not target a specific area on campus. The Representatives would be available for approximately two hours to address any questions/concerns from Staff. - Retirement Walkway-Employee Recognition: Shannon McGee read a letter that she received from Tommye Miller, Chair of the Retirement Walkway Committee.
